The sensors in the vehicle monitors and records what's happening:

- in front of the driver
- in their cabin, as they drive

Acting as a driving 'guardian', it helps keep the driver and other road users safe. The system will alert the driver to distractions (see opposite).

In case of a road incident, the video footage will:

- be supportive evidence for investigations and insurance claims – which also protect employees in case of a claim against them, which can then impact their own personal vehicle insurance policy
- help prevent fraudulent insurance claims
- Fleet managers can then access this data:
- 24/7, in one easy-to-use platform from their desktop or device app
- alongside rich telematics data which can highlight risk areas, to inform effective business decisions e.g. spot congested routes to avoid, to reduce the likelihood of accidents
